PARITY FOR PUERTO RICO MEMORANDUM OF AGREEMENT

Governor Luis G. Fortuño has brought together the undersigned stakeholders in the health care system of Puerto Rico to agree on a common position to present to policymakers in Washington as they debate national health care reform.

We start from a basic proposition. Puerto Rico must be brought into the health care system on an equal basis with every other American jurisdiction. In addition to the clear moral problems inherent in a health care system that treats the U.S. citizens of Puerto Rico in less-than-equal fashion, it makes no sense from a strictly policy perspective to have a system where the same U.S. citizens who receive health care impaired by lesser federal funding while residing in Puerto Rico can access better-funded care merely by moving to the States.

The implementation of our shared objective begins with the federal programs that are likely to serve as the foundation for health care reform—Medicaid, Medicare, and the Children’s Health Insurance Program (CHIP)—and that have been applied to Puerto Rico in an inequitable manner as compared to the States, the District of Columbia, and, in some cases, other territories.

President Obama has pledged to include Puerto Rico in health care reform and to end inequalities in the treatment of Puerto Rico under these aforementioned programs. We, the undersigned, have a common purpose: to advocate for an end to the disparities discussed below as the starting point for implementing health care reform in Puerto Rico:

* **Medicaid:** Federal funding for Medicaid in Puerto Rico is unequal in two respects. First, the federal share of the cost of the Island’s Medicaid program (FMAP) is limited by statute to 50%, whereas it would be up to 83% in a State with Puerto Rico’s per capita income level. But Puerto Rico does not receive even this reduced federal share. Rather, an absolute dollar cap on annual federal funding for Puerto Rico’s Medicaid program means the Island’s effective FMAP is approximately 17% (increased temporarily to about 22% under the recently enacted American Recovery and Reinvestment Act). This requires the Government of Puerto Rico to pay the same percentage share—83%—that the *federal* government would pay in a similarly-situated State. It also prevents the Government of Puerto Rico from being able to provide equal Medicaid services. Puerto Rico has 4.5% of the Nation’s population under the poverty level but receives just 0.13% of Medicaid funds.

* **Medicare:** Residents and healthcare providers in Puerto Rico are unequally treated under Medicare in four respects. (1) Residents of Puerto Rico are not automatically enrolled in Part B, which pays for doctor and other outpatient services. (2) Island hospitals do not receive fair Disproportionate Share Hospital (DSH) payments for serving low-income patients because the Supplemental Security Income program has not been extended to Puerto Rico and the number of SSI recipients is a major factor in the calculation of DSH payments. (3) The Government of Puerto Rico receives limited block grant funding for Part D prescription drug benefits for Medicaid beneficiaries, rather than funding based on the need for medicine. (4) Payments for in-patient hospital services are significantly lower than the reimbursement rates that apply in all other U.S. jurisdictions.

* **Medicare Advantage:** The inequalities facing residents of Puerto Rico have

naturally resulted in a high percentage of these residents enrolling in Medicare Advantage plans. Consequently, reform of the Medicare Advantage program will have a disproportionate impact in Puerto Rico. Any changes, thus, must be addressed in the same-terms and conditions in Puerto Rico as the rest of the nation.


* **CHIP:** CHIP funding in Puerto Rico is unequal because the program's basic funding is granted on a limited set-aside basis rather than based on the number of low-income children.






In support of our position, the representatives of each of the stakeholders execute this Memorandum of Agreement, in San Juan, Puerto Rico, on April 16, 2009.


